- 1. While installing smoke alarms and CO detectors in single family owner-occupied dwellings please be sure to:
 - Review the at-home assessment with the homeowner;
 - Identify fire hazards or unsafe practices; and
 - Educate homeowners on safe habits for home fire prevention.
- 2. Alarms should be utilized for State of Michigan residents in single-family occupied dwellings. Through our data, MI Prevention has identified the following groups as high risk:
 - Men 40 years of age and older.
 - Adults 60 years and older.
 - Children 0-9 years old.
 - Michigan civilians living in poverty.
- 3. One MI Prevention SACk Kit includes:
 - Smoke alarms
 - CO detectors
 - MI Prevention Intro letter
 - MI Prevention Standard operating guidelines (SOG's)
 - Parameters letter, which includes instructions on how to access MIP-DMS (the MI Prevention data management system, or MIP-DMS, that will track smoke alarm and CO detectors requests and installations).

- 4. Smoke Alarms: Install up to six (6) smoke alarms in required areas of the home including:
 - One (1) smoke alarm in each bedroom;
 - One (1) smoke alarm outside of sleeping areas; and
 - At least one (1) smoke alarm on each level of the dwelling.
- 5. CO Detectors: Install one (1) CO detector per home or one on each level of the dwelling based on the risk and needs. The following are acceptable options:
 - One CO detector on each level of the dwelling.
 - One CO detector per home
- 6. Hearing Impaired alarms: Install one (1) hearing impaired alarm with the following rules:
 - One (1) hearing impaired alarm in each bedroom where the hearingimpaired resident sleeps;
 - One (1) smoke alarm in each bedroom;
 - One (1) smoke alarm outside of sleeping areas; and
 - At least one (1) smoke alarms on each level of the dwelling.
- 7. One (1) set of manufacturing instructions shall be given to each homeowner.
- 8. All alarm installations shall be entered in MIP-DMS by the fire department or organization that requested the SACk's.
- 9. The deadlines to install these alarms are designated by each donor and will be outlined when you receive your supply from MI Prevention. If you have any questions regarding your installation deadline, contact MI Prevention Program Manager, Kymberly Pashkowsky.
- 10. While installations are limited to the State of Michigan, there are no restrictions to installing smoke alarms outside of your region, township, etc. MI Prevention encourages you to have your entire family, department and team to have working smoke alarms. Again, the only restrictions are to install the alarms within the State of Michigan.
