- III. Mr. Robinson presented licensee requests for special price reductions on spirit products in accordance with the provisions of the Commission's Order of September 11, 2012 regarding special price reductions on spirit products, which was effective on January 1, 2013. He advised there were forty-four (44) different licensees requesting price reductions; that 454 product price reductions could be approved; and that 1 product price reduction should be denied.

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that the 454 special price reductions be approved as indicated on the attached Approval for Price Reduction on Liquor reports, motion carried by unanimous vote.**

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that the 1 special price reduction be denied for the reasons stated in the attached Notification of Denial for Price Reduction reports, motion carried by unanimous vote.**

- IV. Mr. Robinson presented the November and December 2013 Financial Report which shows the results of our operations for the period of October 1, 2013 through December 31, 2013. He advised most comments will be regarding the December 2013 statement, but wanted to state that in the November report the spirits sales profit and specific spirit tax amounts are low because approximately ½ of the spirit sales for the last week of November 2013 were not recorded until December 2013. Mr. Robinson advised this makes the November 2013 year-to-date profit low by \$11.1 million and each of the three specific taxes are low by \$535.7 thousand. He stated the Total Gross Sales increased over last year by almost \$8.3 million or 2.7%, and the Distilled Spirit cases sold decreased 2,951 or .14%. Mr. Robinson advised the Net Income from spirit sales was up approximately \$1.5 million or 3.0%, and advised Beer taxes are higher by almost \$475,000, with Wine taxes being lower by \$85,000.

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that the November and December 2013 Financial Reports, be accepted, motion carried by unanimous vote.**

- V. Mr. Robinson requested approval to write off a number of uncollectible accounts. He advised this is routine information sent to the Michigan Department of Treasury regarding outstanding debts that the Commission has not been able to collect for

licensees that are no longer active. Mr. Robinson stated that the Michigan Department of Treasury will attempt to collect the debt and if successful, the Commission receives 40% to 50% of the outstanding debt.

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that the information concerning the uncollectible debts be forwarded to the Michigan Department of Treasury for collection, as written and presented, motion carried by unanimous vote.**

- VI. Mr. Robinson presented a request for a Spirit Product Distribution change from Lotte Beverage America Corp. (Lotte), involving five (5) products, to be effective May 4, 2014. He advised that Lotte would like to move these products from Chinese Import & Export to General Wine & Liquor Company, Inc. Mr. Robinson stated this change would consolidate the warehousing and delivery responsibility along with broker representation for all of Lotte's products.

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that Administrative Order 2014-01, regarding the request of Lotte Beverage America Corp., be approved as written and presented, motion carried by unanimous vote.**

Mr. Robinson presented a request for a Spirit Product Distribution change from Hood River Distillers, Inc. (Hood), involving three (3) products, to be effective May 4, 2014. He advised that Hood would like to move these products from NWS Michigan, Inc. to General Wine & Liquor Co. Mr. Robinson stated this change would consolidate the warehousing and delivery responsibility along with broker representation for all of Hood's products.

**Moved by Commissioner Olshove, supported by Commissioner Quimby, that Administrative Order 2014-02, regarding the request of Hood River Distillers, Inc., be approved as written and presented, motion carried by unanimous vote.**

**IX. Public Comments.**

Jim Farrell, CEO of Beverage Merchandising Service, advised the Commission he was there to introduce his service for scanning coupons electronically instead of using paper. He stated that they work in many states with the major brands of distilled spirits and that Michigan is the first control state that they have contacted regarding this service. Mr. Farrell advised that they act as a third party to verify all the information is correct and hopes the Commission would entertain this service in Michigan.

Chairman Deloney advised that approximately 1 ½ years ago, there was some interest in this service and meetings were held. He advised the Commission asked for additional information, but nothing was ever finalized. Chairman Deloney stated the Commission would welcome the opportunity to learn more.

Mr. Farrell stated he would facilitate meetings between the Commission and industry to get the ball moving. He thanked the Commission for their time and advised he would be in touch.

**With no further business, moved by Commissioner Olshove, supported by Commissioner Quimby, that the business meeting be adjourned at 10:10 a.m., motion carried by unanimous vote.**
