The meeting was called to order by Chairman Deloney at 9:32 a.m., noting a quorum was present.

**I. Moved by Commissioner Olshove, supported by Commissioner Quimby that the minutes of the Commission meeting of January 15, 2019, be approved as written and presented, motion carried by unanimous vote.**

**II.** Ms. Hamilton presented the E-Quote report for product listings in three categories (see attached report) and requested approval of the following:

That 65 new items with case size exceptions be approved for listing with an effective date of March 3, 2019, and that 10 new items with case size exception be approved for listing with an effective date of March 31, 2019; and

That 69 regular new items be approved for listing with an effective date of March 3 3, 2019; and that 6 regular new items be approved for listing with an effective date of March 31, 2019; and

That 10 new items with special packaging be approved for listing with an effective date of March 3, 2019, and that 2 new items with special packaging be approved for listing with an effective date of March 31, 2019.

**After discussion, the following products were denied as the Commission does not want to be the wholesaler for these products:**

Luxco, Inc.	50ml Arrow Sup Schnapps	60 Bottles/case
Diageo Americas, Inc.	750ml Orphan Brnl Foragers	6 Bottles/case
Pernod Ricard USA	50ml Jameson (Irish) 4 Pk	120 Bottles/case

**Moved by Commissioner Olshove, supported by Commissioner Quimby that the above actions be taken in accordance with the E-Quote report dated February 7, 2019, as written and presented; motion carried by unanimous vote.**

Ms. Paceagiu presented licensee requests for special price reductions on spirit products in accordance with the provisions of the Commission's Order of September 11, 2012 regarding special price reductions on spirit products, which was effective on January 1, 2013. She advised there were fifty-nine (59) different licensees requesting price reductions; that 1156 product price reductions could be approved; and that 6 product price reductions should be denied.

**Moved by Commissioner Olshove, supported by Commissioner Quimby that the 1156 special price reductions be approved as indicated on the attached Approval for Price Reduction on Liquor reports, motion carried by unanimous vote.**

**Moved by Commissioner Olshove, supported by Commissioner Quimby that 6 special price reductions be denied for the reason stated in the attached Notification of Denial for Price Reduction reports, motion carried by unanimous vote.**
