Occupational Code, Respondents are FINED \$1,000.00, jointly and severally, to be paid

to the State of Michigan within 60 days of the effective date of this Order.

Compliance Section, P.O. Box 30189, Lansing, MI 48909. The fine shall be paid by

check or money order, made payable to the State of Michigan, and the check or money

order shall clearly display file numbers 21-15-327923 and 21-15-327924.

IT IS FURTHER ORDERED that failure to comply with the terms of this

Order shall result in SUSPENSION of Respondents licenses.

IT IS FURTHER ORDERED that in accordance with sections 411(3)(c),

602(c), and 604(k) of the Occupational Code, supra, no application for licensure, renewal,

relicensure, or reinstatement shall be granted until all final orders of the Board have been

satisfied in full.

IT IS FURTHER ORDERED that this Order shall be effective on the date

signed by the Board, as set forth below.

FORMAL COMPLAINT

The Michigan Department of Licensing and Regulatory Affairs

(Complainant) by Kim Gaedeke, Director, Bureau of Professional Licensing, files this

Complaint against Pioneer Homecrafters LLC and George David Brunette (Respondents)

as follows:

1. The Michigan Board of Residential Builders and Maintenance and

Alteration Contractors (Board) is an administrative agency established by the

Occupational Code, MCL 339,101 et seq. Pursuant to section 602 of the Occupational

Code, supra, the Board is empowered to penalize licensees for violations of the

Occupational Code.

- 2. Respondent Pioneer Homecrafters LLC is licensed as a residential builder company, Respondent George David Brunette is licensed as an individual residential builder and is designated as the qualifying officer of Pioneer Homecrafters LLC, and therefore pursuant to section 2405(1) the Occupational Code, <u>supra</u>, is responsible for exercising the supervision or control of the building or construction operations necessary to secure full compliance with the Occupational Code and the rules promulgated under the Occupational Code, <u>supra</u>.
- 3. On April 11, 2015, Casey Lange and Wayne Kooienga acted on behalf of Pioneer Homecrafters LLC and entered into a contract with (Homeowner) to construct a three-season room and install a steel roof over the existing house. A copy of the contract, marked Exhibit A, is attached and incorporated.
- 4. At the time the contract was executed, Casey Lange and Wayne Kooinega were not designated as the qualifying officer of Pioneer Homecrafters LLC and were not licensed as builder salespersons. Wayne Kooinega was issued an individual builder license effective May 28, 1969, the license was suspended on June 13, 1984, and the license expired on May 31, 1985.
- 5. On April 30, 2015, Respondents applied for a building permit that was issued on May 1, 2015. On August 10, 2015, the Egelston Township Building Department approved the final inspection.

6. On October 2, 2015, the Homeowner filed a Statement of Complaint.

COUNT I

Respondents' conduct, as described above, evidences acceptance or performance of a contract procured by a salesperson not licensed under a builder or contractor, or acceptance or performance of a contract, other than the sale of real property, procured by anyone not licensed under the Occupational Code, contrary to Mich Admin Code, R 338.1536, in violation of section 604(h) of the Occupational Code, <u>supra</u>.

COUNT II

Respondents' conduct, as described above, evidences aiding or abetting an unlicensed person to evade this article, or knowingly combining or conspiring with, or acting as agent, partner, or associate for an unlicensed person, or allowing one's license to be used by an unlicensed person, in violation of sections 2411(2)(j) and 604(l) of the Occupational Code, <u>supra</u>.

Complainant requests that this Complaint be served upon Respondents and that Respondents be offered an opportunity to show compliance with all lawful requirements for retention of the license. If compliance is not shown, Complainant further requests that formal proceedings be commenced pursuant to the Occupational Code, rules promulgated thereunder, and the Administrative Procedures Act of 1969, MCL 24.201 et seq.

Pursuant to section 508(2) of the Occupational Code, <u>supra</u>, Respondents have 15 days from the date of receipt of this Complaint to notify Complainant of Respondents decision to either negotiate a settlement of this matter, to demonstrate compliance with the Occupational Code, or to request an administrative hearing. Written notification of Respondents selection shall be submitted to Complainant, Kim Gaedeke, Director, Bureau of Professional Licensing, Department of Licensing and Regulatory Affairs, P.O. Box 30670, Lansing, MI 48909. If Respondents fail to submit written notification within 15 days, this matter shall proceed to an administrative hearing.
