The Marijuana Regulatory Agency (MRA) will hold a public hearing on Thursday, June 13, 2019, at the Williams Building, 525 West Ottawa Street, Lansing, Michigan in the 1<sup>st</sup> Floor Auditorium at 9:30 A.M.

The purpose of this public hearing is to receive public comment on MRA's administration of the Michigan Medical Marihuana Act, 2008 IL 1, as amended, Michigan Medical Marihuana Facilities Licensing Act, 2016 PA 281, Marihuana Tracking Act, 2016 PA 282, and Michigan Regulation and Taxation of Marihuana Act (MRTMA), 2018 IL 1.
