- III. Ms. Paceagiu presented licensee requests for special price reductions on spirit products in accordance with the provisions of the Commission's Order of September 11, 2012 regarding special price reductions on spirit products, which was effective on January 1, 2013. She advised there were fifty nine (59) different licensees requesting price reductions; that 1260 product price reductions could be approved; and that there were six product price reductions to be denied.

**Moved by Commissioner Olshove, supported by Chairman Deloney that the 1260 special price reductions be approved as indicated on the attached Approval for Price Reduction on Liquor reports, motion carried by unanimous vote.**

**Moved by Commissioner Olshove, supported by Chairman Deloney, that the 6 special price reductions be denied for the reason stated in the attached Notification of Denial for Price Reduction reports, motion carried by unanimous vote.**

- IV. Ms. Paceagiu requested approval to write off a number of uncollectible accounts. She advised this is routine information sent to the Michigan Department of Treasury regarding outstanding debts that the Commission has not been able to collect for licensees that are no longer active. Ms. Paceagiu stated that the Michigan Department of Treasury will attempt to collect the debt and if successful, the Commission receives 40% to 50% of the outstanding debt.

**Moved by Commissioner Olshove, supported by Chairman Deloney, that the information concerning the uncollectible debts be forwarded to the Michigan Department of Treasury for collection, as written and presented, motion carried by unanimous vote.**

- V. Ms. Paceagiu advised that NWS has asked that four (4) liquor codes for Ivanabitch products be delisted. She stated that the vendor, International Spirits, is no longer shipping product to the warehouse and they are not responding to our letters. Ms. Paceagiu advised Treasury will be deleting them as the liquor payments are being returned.

**Motion by Chairman Deloney, to approve the delisting of four (4) Ivanabitch product codes as the vendor has gone out of business. Supported by Commissioner Olshove, the motion was carried by unanimous vote.**

- VI.** Chairman Deloney advised a recent declaratory ruling request from the Michigan Spirits Association was approved on March 3, 2017, to allow them to place promotional items on alcoholic beverage bottles in a retailer's inventory. He stated upon further review of the request, it was concluded that the Commission erred in granting the request as it failed to present an actual state of facts, including all relevant and material facts.

**Motion by Chairman Deloney, to rescind its March 3, 2017 declaratory ruling. Supported by Commissioner Olshove, the motion was carried by unanimous vote.**
