New On-Premises Specially Designated Merchant (SDM) Application

A Specially Designated Merchant (SDM) license, which allows for the sale of beer, wine, and mixed spirit drink products in the original, unopened container for consumption off the licensed premises, may be issued under MCL 436.1533(5)(a) to a licensee that holds a **Class C, B-Hotel, Tavern, A-Hotel, Club, G-1**, or **G-2** license. A SDM issued under this section is not subject to the SDM license quota and may not be transferred to a new location. This application does not qualify for a conditional license pursuant to MCL 436.1525(6)(c). A Club, G-1, or G-2 licensee issued a SDM license may only sell beer, wine, and mixed spirit drink products for consumption off the premises to a bona fide member.
