The licensing hearing was conducted for Nuculovic G, LLC, Request ID# 675205. Susan Moody appeared on behalf of the Attorney Generals Office, Attorney Frank Palazzolo and Deljos Nuculovic, member, appeared on behalf of the applicant. Also present was Timothy Chase, member of Family First Enterprises, L.L.C. Ms. Moody and Mr. Palazzolo offered comments regarding this case.
