Chairman Deloney called the hearings to order at 10:00 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Chairman Deloney, that the minutes of the Southfield Appeal Hearings of August 8, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Spencer Soka, Inc., 313 E. Grand River, East Lansing, Ingham County  
Request ID# 670880

The licensing hearing was held for Spencer Soka, Inc., Request ID# 670880, which was tabled from the appeal hearing held August 8, 2013. Rosendo Asevedo appeared on behalf of the Attorney Generals Office and no one was present for the applicant. After discussion on the record, Chairman Deloney made a motion to affirm the previous Commission Order of denial dated July 10, 2013, and deny the request for a new Class C license issued under the provisions of MCL 436.1521a(1)(b) and consideration of licensing pursuant to administrative rule R 436.1121(2)(f). Commissioner Olshove supported and the motion was carried by unanimous vote.

3. D & Z LLC, d/b/a Goodfellas Lounge, 20912 Harper, Harper Woods, Wayne County  
Complaint No. 2-153916

The violation hearing was held D & Z LLC, Complaint No. 2-153916. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Frank Palazzolo and Elias Zedan, member, appeared on behalf of the licensee. Mr. Asevedo, Mr. Palazzolo and Mr. Zedan offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to modify the order of Hearing Commissioner Edward D. Clemente, dated June 5, 2013, by

reducing the ten (10) day suspension to a seven (7) day suspension starting September 6, 2013. Commissioner Olshove supported and the motion was carried by unanimous vote.

4. Hoover Party Store, Inc., 24005 Hoover, Warren, Macomb County

This licensing hearing was conducted for Hoover Party Store, Inc., Request ID# 703054. Rosendo Asevedo appeared on behalf of the Attorney Generals Office, Attorney Frank J. Palazzolo and Saood Jarbo, sole stockholder, appeared on behalf of the applicant. Mr. Asevedo and Mr. Palazzolo offered comments regarding this case. After discussion on the record, Chairman Deloney advised the matter would be tabled to a hearing on a future date.
