Chairman Deloney called the hearings to order at 10:11 a.m., noting a quorum was present.

1. Moved by Commissioner Olshove, supported by Commissioner Quimby, that the minutes of the Southfield Appeal Hearings of September 19, 2013, be approved as written and presented, motion carried by unanimous vote.
2. Good Times Party Store II, Inc., D/B/A Good Times, 22900 Harper, St. Clair Shores, Macomb County Request ID# 705539

The licensing hearing was held for Good Times Party Store II, Inc., Request ID# 705539. Linda Pytel-McDowell appeared on behalf of the Attorney General's Office, Attorney Frank Palazzolo and David Hurd, stockholder appeared on behalf of the applicant. Ms. Pytel-McDowell, Mr. Palazzolo and Mr. Hurd offered comments regarding this case. After discussion on the record, Chairman Deloney made a motion to reverse the previous Commission Order of denial dated August 9, 2013, and approve the request to transfer all stock interest in the 2013 SDD and SDM licensed business with Sunday Sales Permits (AM & PM), as set forth in the Licensing Appeal Order. Commissioner Olshove supported and the motion was carried by unanimous vote.

3. Colonial Lodging, Inc., D/B/A Day's Inn, 10780 S. Telegraph, Taylor, Wayne County Request ID# 416038
