III. Mr. Robinson presented the January 2014 Financial Report which shows the results of our operations for the period of October 1, 2013 through January 2014. He advised the report will contain three (3) extra sales days when compared to last year. Mr. Robinson stated the Total Gross Sales increased over last year by almost \$15.6 million or 4.0%, and the Distilled Spirit cases sold decreased 19,479

or .7%. He advised the Net Income from spirit sales was up approximately \$1.0 million or 1.7%, and that Beer taxes are higher by almost \$576,000, with Wine taxes being lower by \$81,000.
