Mr. Geissler, Mr. Isaac, Mr. Green and Pastor Davis offered introductory comments regarding this case. Commissioner Quimby began with the procedural issue of whether or not this church meets the definition in the MLCC Code for a church, and whether or not the church hearing could proceed.

The hearing was recessed at 11:24 a.m.

The Church hearing was reconvened at 11:33 a.m. Present were Commissioner Quimby and Commissioner Olshove; absent was Chairman Deloney.

After discussion on the record, Commissioner Quimby advised that under Michigan Administrative Code R 436.1959(2), the representative of the church shall be prepared to show that the church which is objecting meets the definition contained in MCL 436.1107(7). The definition states that "Church" means an entire house of structure set apart primarily for use for purposes of public worship, and which is tax exempt under the laws of this state, and in which religious services are held and

with which a clergyman is associated, and the entire structure of which is kept for that use and not put to any other use inconsistent with that use.”

Commissioner Quimby stated that by their own statements on the record the Integrity House of Worship-Church of the Living God could not meet the tax exempt requirements of the definition. Mr. Geissler agreed with this finding. Commissioner Quimby stated the only conclusion of law that can be reached is that the church hearing cannot proceed.

Commissioner Quimby made a motion that since the Integrity House of Worship-Church of the Living God does not appear to meet the definition contained in the MLCC Code, the hearing cannot continue and the matter is dismissed, as set forth in the Church Hearing Order. Commissioner Olshove supported and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Quimby and supported by Commissioner Olshove, that the Appeal Hearings be adjourned at 11:46 a.m., motion carried by unanimous vote.
