Attorney Michael Brown advised the Commission that one of his clients had a conditional license issued, and the seller's license to be transferred was automatically placed into escrow at the time of issuance of the conditional license. However, since the conditional license is mailed, which can take 5-7 days, this created a period of time when the seller had an inactivated license and the buyer (the conditional licensee) did not yet have the conditional license in hand. This creates a problem of a period of non-licensure and also effects the ability for alcohol ordering, and well as being subjected to a possible violation during this time frame. Commissioner Quimby acknowledged that this appears to be, in effect, an unintended automatic suspension of a license due to the mailing time involved. She stated that she would bring it to Chairman Deloney's attention.

The meeting was called to order by Chairman Deloney at 9:36 a.m., noting a quorum was present.

Attorney Michael Brown requested an update on the procedure of automatically escrowing a current license when a conditional license for that location has been issued. Chairman Deloney advised there have been discussions with staff and that has brought up other issues, some technical, that have to be reviewed. He stated we should have the problem resolved shortly.
