 CHARGE : 1) FAILED TO COOPERATE WITH AND/OR OBSTRUCTED COMMISSION INVESTIGATORS IN THE COURSE OF INSPECTING OR INVESTIGATING THE LICENSED PREMISES; 2) FAILED TO MAKE REQUIRED RECORDS AVAILABLE FOR INSPECTION; 3) FAILED TO MAINTAIN ACCURATE RECORDS OF ALCOHOLIC LIQUOR PURCHASES AND SALES, SPECIFICALLY: BEER/WINE & LIQUOR PURCHASES; 4) FAILED TO MAINTAIN APPROPRIATE RECORDS FOR 4 YEAR PERIOD OF TIME; 5) POSSESSED, SOLD, OFFERED FOR SALE, OR EXPOSED FOR SALE ALCOHOLIC LIQUOR, VODKA, WHICH WAS ADULTERATED, MISBRANDED OR REFILLED; 6) SOLD, FURNISHED OR ALLOWED CONSUMPTION OF ALCOHOLIC LIQUOR OR POSSESSED ALCOHOLIC LIQUOR ON LICENSED PREMISES, NOT PURCHASED FROM AN AUTHORIZED SOURCE; 7) PURCHASED WITHIN ONE MONTH PERIODS MORE THAN 9 LITERS OF SPIRITS FROM SUPER S WINE SHOPPE; 8) SOLD/FURNISHED ALCOHOLIC BEVERAGES WITHOUT FULLY COMPLYING WITH THE PROVISIONS OF THE MICHIGAN LIQUOR CONTROL CODE BY FAILING TO PROVIDE PROOF OF FINANCIAL RESPONSIBILITY, WHICH RESULTED IN A SUSPENSION BASED ON AN ORDER OF THE COMMISSION DATED 12/3/13; 9) FAILED/REFUSED/NEGLECTED TO OBEY A WRITTEN ORDER OF MLCC DATED 12/3/13; 10) ALLOWED THE SALE, POSSESSION, OR USE OF A CONTROLLED SUBSTANCE ON THE LICENSED PREMISES, SPECIFICALLY: MARIJUANA; 11-21) FAILED TO COMPLY WITH ALL STATE & LOCAL BUILDING, PLUMBING, ZONING, SANITATION & HEALTH LAWS, RULES & ORDINANCES, SPECIFICALLY: PROVIDE SANITIZER KIT THAT MEASURES SANITIZING SOLUTIONS, SOILED NON-FOOD CONTACT SURFACES, EMPLOYEE(S) SMOKING IN BAR, NON TIGHT-FITTING OUTER OPENING(S), PROVIDE A HANDWASHING SIGNAGE AT HAND SINK, NOT REMOVING EQUIPMENT/UNNECESSARY ITEMS THAT ARE NONFUNCTIONAL, EMPLOYEE(S) DID NOT WASH THEIR HANDS AFTER TOUCHING BARE HUMAN BODY PARTS, PACKAGED FOOD LABEL(S) DID NOT INCLUDE NAME, ADDRESS OF MANUFACTURER, PROVIDE SIGNS THAT WILD GAME SERVED HAS NOT BEEN SUBJECT TO STATE OR FEDERAL INSPECTION, PROVIDE PROPER DATE MARKS FOR IN-HOUSE PREPARED READY-TO-EAT FOOD(S), PROVIDE SANITARY HAND DRYING PROVISIONS : (LCC INV SWOPE, MARSHALL, TOMA)  
 COMM. ORDER : 09-16-2014 HEARING HELD SOUTHFIELD GAFFNEY/MCDOWELL/GIBSON NEG SETTLEMENT  
 10-17-2014 AS PENALTY, THE COMMISSIONER ORDERS THE LICENSEE TO PAY A FINE OF \$300 FOR EACH OF THE TEN (10) ACKNOWLEDGED VIOLATIONS IN THIS COMPLAINT, FOR A TOTAL FINE OF \$3,000. IN ADDITION, THE COMMISSIONER ORDERS THAT A SUSPENSION OF 150 CONTINUOUS DAYS BE IMPOSED IF THE TOTAL FINE OF \$3,000 IS NOT PAID WITHIN FORTY-FIVE (45) DAYS FROM THE DATE THIS ORDER IS MAILED. THIS SUSPENSION, IF SERVED, SHALL BE SERVED CONSECUTIVELY AND NOT CONCURRENTLY WITH ANY OTHER SUSPENSIONS ORDERED BY THE MLCC FOR THIS LICENSEE.  
 AS ADDITIONAL PENALTY, THE COMMISSIONER ORDERS ALL LICENSES AND PERMITS ISSUED BY THE MLCC TO THIS LICENSEE AT THE ABOVE-NAMED ADDRESS SUSPENDED FOR A PERIOD OF THREE (3) CONTINUOUS DAYS. THIS SUSPENSION IS HEREBY WAIVED AND IS TO SERVE AS A WARNING THAT ANY FUTURE VIOLATIONS INVOLVING ANY OF THE ABOVE TEN (10) ACKNOWLEDGED CHARGES, WITHIN THE NEXT TWENTY-FOUR (24) MONTHS, WILL LEAD TO LICENSE SUSPENSION. ANY VIOLATION OF THE MICHIGAN FOOD CODE MUST BE OF A SUBSTANTIAL NATURE SO AS TO THREATEN THE HEALTH, SAFETY AND/OR WELFARE OF THE PUBLIC.  
 FURTHER, THE COMMISSIONER ORDERS CHARGE NO. 10, CITED ABOVE, DISMISSED, WITH PREJUDICE.
