5. Calculate the tax amount by multiplying the amounts in Columns 3 and 4 and entering the result in Column 5.
6. Add all the amounts in Column 5 and enter the Total Payment Due at the bottom of Column 5.
7. Make check payable to **State of Michigan/MLCC**. Please write license number on check.
8. If applicable, complete the Outstate Self-Distributor Monthly Report of Spirits Sales (LCC-822).
9. Record the total out-of-state spirits sales to retailers (listed in gallons only) during the reporting period, whether or not there were any sales in Michigan. Total combined spirits sales to retailers for the calendar year cannot exceed 3,000 gallons.
10. Mail check and this report and the LCC-822 report (if applicable) to address at the top of this form.
