The meetings will begin at the regularly scheduled time, but members of the public may access each meeting at the above web link or phone number 10 minutes before it begins.

During the time designated by the Board for public comment, members of the public will no longer be muted and may participate and provide their comments by orderly speaking using the microphone on their device or phone or by typing their comments into the chat function. All existing Board rules regarding public comment (including rules designed to minimize disruptions and allow for full public participation) still apply.

All quorum rules still apply. In the event of a disconnection caused by the meeting host, the Board will be considered to be in recess. Every effort will be made to reestablish a publicly accessible connection. If the host is unable to do so within a period of 30 minutes from the time of the disconnection, the Board will adjourn and not address any new business until its next meeting. Any valid decisions made prior to the disconnection will be binding. The Board will not recess or adjourn due to technical or other issues experienced by individual members of the public that render them unable to attend or participate in the meeting.

To allow for broad public attendance and participation, including for persons with disabilities, members of the public may access the Zoom meetings by both web and phone and provide either oral or written comments. Closed captioning will be provided, when available. Members of the public who are speech or hearing impaired may also attend and participate in each meeting by dialing 7-1-1 and using the Michigan Relay service.
