Schedule of Accounting Periods

This bulletin shows the schedule of the Commission's accounting periods for the fiscal years 2017 through 2019. The schedule, dated September 15, 2017, designates accounting week numbers, corresponding week ending dates, number of weekdays per month, total weekdays per fiscal year, and accounting month periods. Week 1 of the 2018 fiscal year has a week ending date of 10-7-17 and includes 5 week days.
Week 52 of the 2018 fiscal year has a week ending date of 09-30-18 and includes 5 week days.

Week 1 of the 2019 fiscal year has a week ending date of 10-06-18 and includes 5 week days.
Week 52 of the 2019 fiscal year has a week ending date of 09-30-19 and includes 6 week days.
