## Introduction

**Public Act 187 of 2010, Section 714** requires that the department shall report to the legislature on the timeliness of nursing facility complaint investigations and the number of complaints that are substantiated on an annual basis. The report shall consist of the number of complaints filed by consumers and the number of facility-reported incidents. The department shall make every effort to contact every complainant and the subject of a complaint during an investigation.

The information provided is based on data for the period October 1, 2010 through September 30, 2011.
