Electrical, Mechanical and Plumbing: Estimated Cost to Process an Initial License Application - with Veteran Exemption	\$40.29
Electrical, Mechanical and Plumbing: Estimated Cost to Process a Renewal Application - Regular	\$29.74
Electrical, Mechanical and Plumbing: Estimated Cost to Process an Examination Application - Regular	\$106.71

All of the above estimated costs were calculated by conducting a time study of numerous industry examination, initial and renewal application processes. These costs reflect the average processing time for an application only and do not include the daily cost for administration and enforcement.

Examples of the various steps in the application process is: development of examination questions, review of qualifications, receipts accounting printing and mailing services, supply costs (envelopes, toner, postage, etc.), development of website instructions and information, communication with reporting requirements, etc.

All examinations are now being conducted by a third party, PCI. The bureau reviews the applications and provides questions for the examination.
