**Bureau Updates**

State Fire Marshal (SFM) Julie Secontine gave an update on the Accela software program which is moving forward with the Storage Tank Division (STD) and are now in the process of working on the Fireworks program.

SFM Secontine has stood up the Fire Service Coordination Committee (FSCC) which has several workgroup committees within the FSCC, and includes about 40 members from around the state, which will meet on a monthly basis. All the fire groups have been allowed to assign one representative on the committee and several others were handpicked. The FSCC has been broken down to the following workgroups:
