All quorum rules still apply. In the event of a disconnection caused by the meeting host, the Commission will be considered to be in recess. Every effort will be made to reestablish a publicly accessible connection. If the host is unable to do so within a period of 30 minutes from the time of the disconnection, the Commission will adjourn and not address any new business until its next meeting. Any valid decisions made prior to the disconnection will be binding. The Commission will not recess or adjourn due to technical or other issues experienced by individual members of the public that render them unable to attend or participate in the meeting.

Closed captioning will be provided, when available.
