MOTION: It was moved by Mr. McKart and supported by Mr. Viviano that the following penalty be assessed: Dissolve the current Summary Suspension and Cease and Desist order against Respondent's Professional Boxing license; 90 day suspension of Respondent's Professional Boxing license with a credit for time served, or until the fine and administrative costs are paid in full, whichever is later; a fine in the amount of \$500.00 plus administrative costs in the amount of \$500.00 made payable to the State of Michigan within sixty (60) days from the date of mailing of the Final Order for Complaint No. 331375. The motion carried by unanimous vote.

### **JOVAN BLAKELY LICENSE NO. 15-02-013713, SUMMARY SUSPENSION 01-11-2017, DETROIT, MI: COMPLAINT NO. 331391**

MOTION: It was moved by Mr. Bocks and supported by Mr. Viviano that the following penalty be assessed: Dissolve the current Summary Suspension and Cease and Desist order against Respondent's Professional Boxing license; Immediate suspension of Respondent's Professional Boxing license until 90 days after the fine and administrative costs are paid in full; a fine in the amount of \$500.00 and an administrative fine in the amount of \$500.00 made payable to the State of Michigan within sixty (60) days from the date of mailing of the Final Order for Complaint No. 331391. The motion carried by unanimous vote.

### **JAAFAR BOXING, LLC, LICENSE NO. 15-10-013418, ACTIVE 08-31-2017, DES DEARBORN, MI: COMPLAINT NO. 331016**

MOTION: It was moved by Mr. Hundley and supported by Mr. Bocks that the following penalty be assessed: Dissolve the current Summary Suspension and Cease and Desist order against Respondent's Professional Promoter license; 180 day suspension of Respondent's Professional Promoter license until the fine and administrative costs are paid in full, whichever is later; a civil fine in the amount of \$5,000.00 plus administrative costs in the amount of \$2,500.00 made payable to the State of Michigan within sixty (60) days from the date of mailing of the Final Order for Complaint No. 331016. The motion carried by unanimous vote.
