FINAL ORDER GRANTING LICENSURE

On or about on March 11, 2016, Petitioner filed with the Michigan Board of Residential Builders and Maintenance and Alteration Contractors (Board) an application for relicensure to practice as an individual maintenance and alteration contractor in the state of Michigan with supporting documents.

On October 3, 2016, the Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing (Department), executed a Notice of Intent to Deny Application for Licensure, alleging applicant did not meet one or more of the requirements for licensure pursuant to the MCL 339.2404(1).

The Board, having reviewed the administrative record, considered Petitioner's oral statement regarding this matter at a regularly scheduled meeting held in Lansing, Michigan on June 13, 2017. Therefore,

IT IS ORDERED that Petitioner is GRANTED a limited license to practice as an individual maintenance and alteration contractor PROVIDED the Department receives satisfactory written evidence that Petitioner has met all requirements for relicensure.

IT IS FURTHER ORDERED that Petitioner's license shall be LIMITED for a minimum of two years commencing on the effective date of relicensure subject to the following terms of probation:

1. BOOKS AND RECORDS: Petitioner shall submit a copy of the books and records related to his business to the Department every six months, as further provided herein.
2. REPORT OF BUSINESS OPERATIONS AND PERSONAL WELL-BEING: Petitioner shall submit reports advising of Petitioner's business operations and personal well-being to the Department every six months, as further provided herein.
3. REPORT OF VIOLATION OF ANY CRIMINAL LAW OF ANY UNIT OF GOVERNMENT: Petitioner shall immediately report any criminal law violation to the Department, as further provided herein.
4. COMPLIANCE WITH THE OCCUPATIONAL CODE: Petitioner shall comply with all applicable provisions of the Occupational Code and rules promulgated thereunder.
5. REPORTING PROCEDURE: Unless immediate notification is required as indicated above, all reports required by this Order shall be filed every six months. The first report shall be filed at the end of the sixth month of probation and subsequent reports every six months thereafter.

Petitioner shall direct all reports and communications required by the terms of this

Order to: Department of Licensing and Regulatory Affairs, Enforcement Division, Compliance Section, P.O. Box 30670, Lansing, MI 48909.

6. COSTS: Petitioner shall be solely responsible for payment of all costs incurred in complying with the terms of this Order.

IT IS FURTHER ORDERED that Petitioner may petition for reclassification of the limited license two years from the effective date of this Order.

IT IS FURTHER ORDERED that in the event Petitioner violates any provision of this Order, the Board may proceed to take disciplinary action pursuant to MCL 339.604(k).

This Order is a public record required to be published and made available to the public pursuant to the Michigan Freedom of Information Act, MCL 115.231 *et seq.*

IT IS FURTHER ORDERED that this Order shall be effective on the date signed by the Board's Chairperson or authorized representative, as set forth below.
