Provisions have been made for the school to be under the daily supervision of a licensed instructor who has at least 3 years' experience in all services taught at the school.	§1205(1)(d)
Possess efficient apparatus and equipment for teaching of the curriculums offered.	§1205(2)(b)
Shall maintain 1 person licensed as an instructor, competent to impart instruction in each subject of its curriculum, for every 20 students.	§1205(2)(c)
School and instructor licenses displayed in a prominent place visible to the public.	§1205(2)(h)
A sign shall be displayed indicating services are rendered by students of the school.	§1205(2)(i)
Student is furnished with a copy of financial contract showing the total cost and all charges involved in the complete course of study.	§1205(2)(j)

School shall have instructional visual aids for teaching the prescribed curriculum, one bulletin board in the student area, seating facilities for patrons, one chair that has writing facilities for each attending student, sufficient practical training stations & equipment so that students are not required to share a station during practical training periods, a shampoo bowl installed in a classroom other than the main clinic classroom, adequate space per attending student for theory & non-practical classroom training, a chalk board or the equivalent of sufficient size to be seen from the back of the room in which it is used.? A school shall furnish a copy of the act and these rules to each student.	R 37(1)
The school shall provide all necessary materials, equipment and supplies are furnished to students for work performed on the public.	R 37(2)
The contract between the student and school shall contain a list of charges for additional materials, supplies, or equipment other than that required to adequately train students.	R 37(2)
A school shall ensure they have all of the following: Adequate supply of running hot and cold water; adequate electrical outlets and wiring to supply all electrical equipment used; adequate lighting and ventilation in all rooms; floors, walls and ceilings maintained in good conditions; a source of drinking water in an area other than that used to mix chemicals; covered waste containers that are large enough to contain one day's accumulation of waste materials. Chairs and work station surfaces are clean and sanitary at all times, covering the headrest of patron chair and working surface of any table or chair covered with fresh, clean paper, linen, or cloth before each use.	R 73(2)

Sanitation procedures followed-sanitize equipment, tools, implements & supplies that will not be damaged by mmersion in water using all of the following: Thoroughly washing in a detergent solution; rinsing in clean water; completely immersing in a wet sanitizer for the period of time recommended by the manufacturer of he disinfectant used; rinsing in clean water and allowing to air dry; sanitize other equipment, tools, mplements, and supplies by wiping with a disinfectant solution; sanitize sharp-edged tools, including the blades of electrical clippers by wiping with a 70% alcohol solution after each use; ensure that after sanitation, he equipment, tools, implements, and supplies are put in a dry sanitizer, closed cabinet or drawer, or covered container?
