Display its license for the school of cosmetology and the license of each instructor who works in the school in a prominent place in the school that is visible to the public at all times.	§1205(2)(h)
Display a sign in the school that states that services are performed by students of the school.	§1205(2)(i)

School shall have seating facilities for patrons; an adequate number of chairs and adequate desk space to meet the needs of each student attending; if services are performed on the public, an adequate amount of equipment, supplies, and tools necessary for performing services on patrons in compliance with the requirements under part 4 of the rules; shampoo bowls in classroom other than the clinic classroom, unless a limited school of electrolysis; if services are not performed on the public, an adequate amount of equipment, supplies, and tools necessary for providing the theory hour and practical training offered on the premises. Covered waste containers that are large enough to contain one day's accumulation of waste materials. Waste containers are disinfected at least once every 24 hours or lined with a plastic bag that is disposed of each time the waste container is emptied.
