

The Settlement Agreement resolves all of the allegations contained in the Order of Summary Suspension and Notice of Intent to Revoke Certificate of Registration dated December 10, 2015.

The Michigan Administrative Hearing System has removed this case from its docket, cancelled the hearing scheduled for February 26, 2015, and closed its file in this matter.



SETTLEMENT AGREEMENT

In The Matter Of:

On December 10, 2014, the Bureau of Children and Adult Licensing issued an Order of Summary Suspension and Notice of Intent to Revoke the family child care home certificate of registration of Christine Youle.

In settlement of all issues raised in the Order of Summary Suspension and Notice of Intent to Revoke, the undersigned parties hereby agree:

- 1) Christine Youle neither admits nor denies the allegations set forth in the Order of Summary Suspension and Notice of Intent to Revoke; however, Ms. Youle admits to a violation of the Child Care Organizations Act and/or a licensing rule promulgated under the Act.
- 2) Christine Youle understands that her family child care home certificate of registration will be revoked, effective the date of the signature by the representative of the Bureau of Children and Adult Licensing. Ms. Youle agrees to immediately cease providing care to unrelated children in her home.
- 3) Christine Youle understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine.
- 4) Christine Youle understands that she is waiving her right to appeal the Order of Summary Suspension and Notice of Intent to Revoke her certificate of registration, and an administrative hearing will not be held in this matter.
- 5) Christine Youle agrees not to apply for a license or certificate of registration for a Child Care Organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.
