SETTLEMENT AGREEMENT

In The Matter Of:

On April 8, 2015, the Bureau of Children and Adult Licensing issued *Special Investigation Report #2015A0866029* recommending revocation and summary suspension of the adult foster care large group home license of Empey's AFC Inc.

In settlement of all issues raised in *Special Investigation Report #2015A0866029* the undersigned parties hereby agree:

- 1) Empey's AFC Inc. and Licensee Designee Susan Empey neither admit nor deny the allegations set forth in *Special Investigation Report #2015A0866029* but agree that a violation of the Adult Foster Care Facility Licensing Act and/or the rules promulgated under this Act has occurred.
- 2) Empey's AFC Inc. and Licensee Designee Susan Empey understand that License #AL320071678 will be revoked, effective the date of the signature by the representative of the Bureau of Children and Adult Licensing.
- 3) Empey's AFC Inc. and Licensee Designee Susan Empey agree to cease providing adult foster care services as defined under the Act, effective April 9, 2015.
- 4) Empey's AFC Inc. and Licensee Designee Susan Empey understand that they are waiving their right to appeal the revocation, and an administrative hearing will not be held in this matter.
- 5) Empey's AFC Inc. and Licensee Designee Susan Empey agree not to apply for a license for an adult foster care organization licensed under the Adult Foster Care Facility Licensing Act for a period of five years, and agree not to be connected, directly or indirectly, with a licensee for a period of five years from the effective date of this agreement.

- 6) Licensee Designee Susan Empey understands that pursuant to MCL 400.731(1), operating an adult foster care facility without a license is a violation of the Adult Foster Care Licensing Act and a misdemeanor, punishable by imprisonment up to 1 year or a fine of not more than \$1,000, or both.
