SETTLEMENT AGREEMENT

In The Matter Of:  
Magical Years Child Development Center, Inc.

On December 30, 2014, the Bureau of Children and Adult Licensing issued a *Notice of Intent to Revoke* the child care center license of Magical Years Child Development Center, Inc. Sandra Thayer is the Licensee Designee and Administrator of this facility and signs on behalf of the licensee corporation, Magical Years Child Development Center, Inc. In settlement of all issues raised in the *Notice of Intent to Revoke*, the undersigned parties hereby agree:

- 1) Sandra Thayer has filed an appeal to the *Notice of Intent to Revoke*, making certain admissions and denials, but now desires for this license to be closed without further proceedings or factual determination.
- 2) Sandra Thayer understands that Magical Years Child Development Center's child care license will be revoked effective April 11, 2015.
- 3) Sandra Thayer understands that under MCL 722.125, Section 15(1), a person who provides child care without a license or certificate of registration is guilty of a misdemeanor, and the offense is punishable by up to 90 days imprisonment and/or a \$1,000 fine. Ms. Thayer agrees that she will cease operation of Magical Years Child Development Center by April 11, 2015.
- 4) Sandra Thayer understands that she is waiving her right to appeal the *Notice of Intent to Revoke*, and an administrative hearing will not be held in this matter.
- 5) Sandra Thayer agrees not to apply for a license or certificate of registration for a child care organization licensed or registered under the Child Care Organizations Act for a period of two years, and agrees not to be connected, directly or indirectly, with a licensee or registrant for a period of two years from the effective date of this agreement.

6) This agreement does not prohibit Ms. Thayer from being employed in a child care setting provided that she does not assume the position of registrant, licensee, licensee designee or program director.
