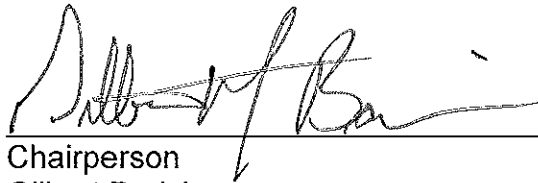

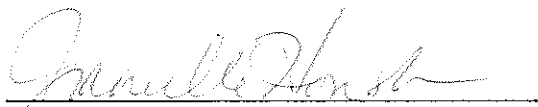
The next regularly scheduled meeting of the Board of Professional Surveyors will be held on September 9, 2015, Conference Room 1, at 9:00 a.m.
