- D.** The 2015 Michigan Plumbing Code committee work was completed based on the 2015 International Plumbing Code with changes.

- F. Ms. Jennifer Little will fill in for Mrs. Sara Leiby while she is on maternity leave.
- G. Committee work on the 2015 Energy Code began June 1, 2015.
