The MIOSHA and MALA Alliance will provide MALA members and others with information, guidance, and access to training resources that will help them protect the health and safety of workers, particularly by reducing and preventing exposure to sprains and strains, blood borne pathogens, slips, trips, falls, workplace violence, as well as employee safety and resident rights issues; and understand the rights of workers and the responsibilities of employers under the Michigan Occupational Safety and Health Act (MIOSH Act).

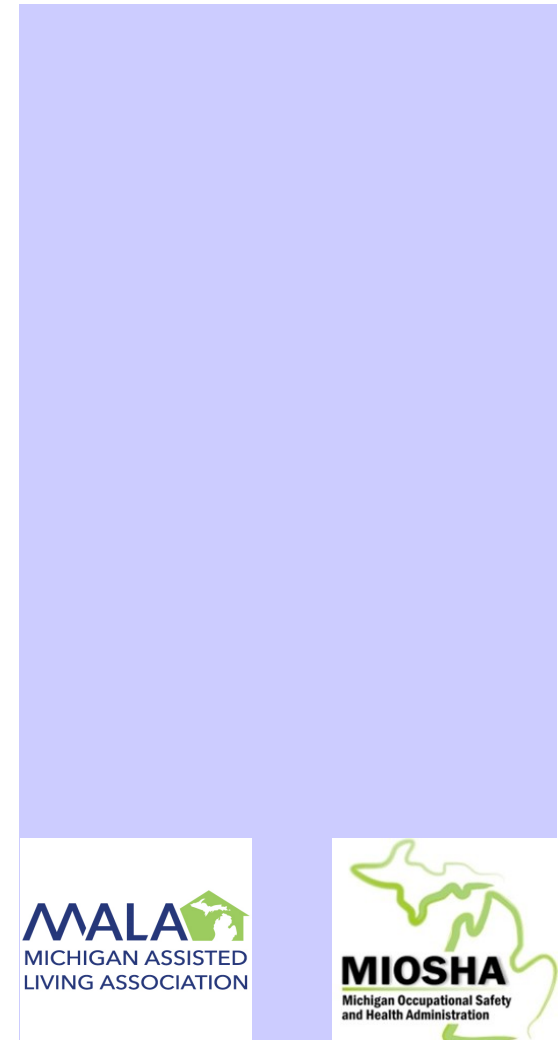
Major Goals of the Alliance: include

### Training and Education

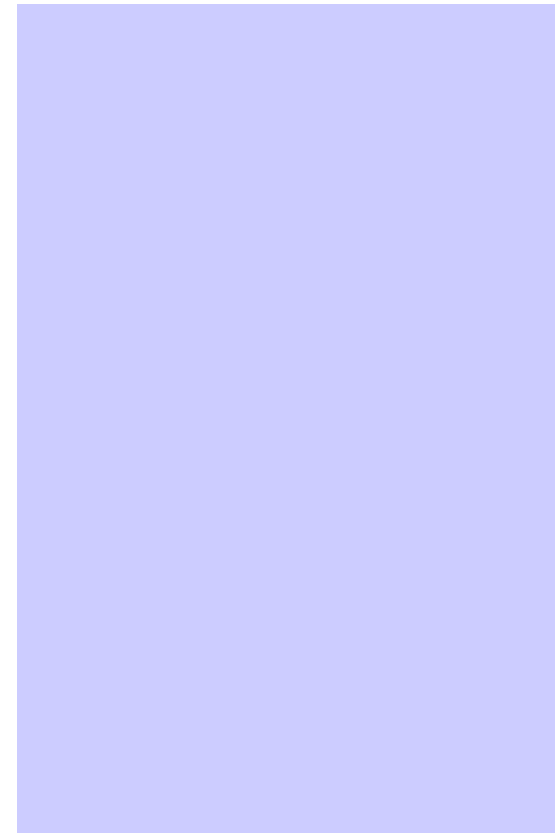

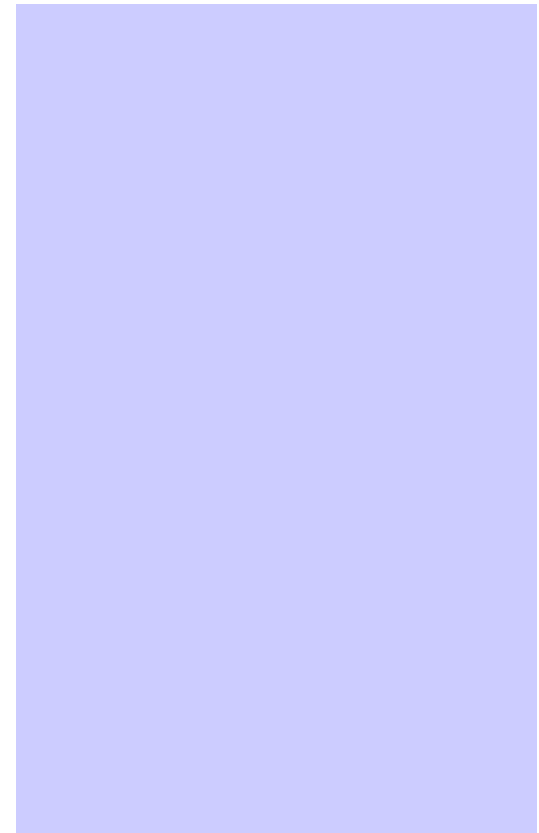

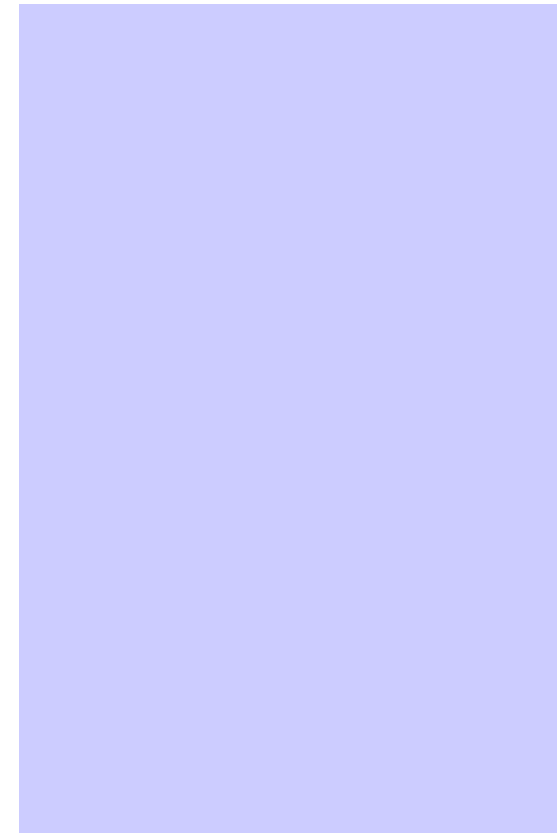
