Encapsulants are coatings usually sprayed or rolled onto surfaces. This makes a long-lasting barrier between lead-based paint and human contact. **Regular latex paints are not encapsulants!**

When encapsulants are used for lead abatement purposes the work must be performed by certified lead abatement professionals. Homeowners may apply encapsulants to their own homes during remodeling, renovating and painting projects if they do the work themselves. Manufacturers' instructions must be read carefully to determine if an encapsulant is an appropriate option, and proper surface preparation and all application procedures listed on the label must be followed.

The State of Michigan does not test encapsulants, but approves materials based on an encapsulant product's compliance with ASTM standards. The following is a list of encapsulant products that have been accepted for use in Michigan for lead abatement projects. This is not intended to be an exhaustive list and is provided solely as an information service. The State of Michigan does not endorse or recommend any encapsulant. Other encapsulant products may be used if they meet the correct ASTM International Standard. The label should state it meets either <u>ASTM E 1795</u> for liquid encapsulant products or <u>ASTM E 1797</u> for reinforced liquid encapsulant products. If the product does not have one of these ASTM standard numbers, it is not approved for use in the State of Michigan.
