- <u>Talent Cultivation & Aptitude Pairing Workgroup</u> Lead by Jenny Geno, joined by Lee Graham, Rachel Lutz and Megan Schrauben, this group will cultivate programs such as Futures for Frontliners and Reconnect and others.
