Notice of Reduction in Force Re:

Dear Mr. Howard:

I am writing on behalf of Progenity, Inc. to give you notice that there will be a reduction in force at the Ann Arbor location of Progenity, which is located at 5210 and 5230 S. State Road, Ann Arbor, Michigan, effective on August 6, 2021. This mass layoff is expected to be permanent and will affect 110 Progenity employees at the Ann Arbor location.

Because this will impact a business within your geographical jurisdiction, this written notice is being provided at this time in accordance with the provisions of the federal Worker Adjustment and Retraining Notification Act ("WARN"), 29 U.S.C. §§ 2101 et seg. All affected employees are being concurrently notified of the August 6, 2021 separation date and that their separation from employment will be permanent. The affected employees are also being notified that if Progenity no longer needs them to perform work at some time prior to August 6, they will be placed on paid leave (during which benefits will be maintained and continue to accrue) until August 6, 2021.
