If you need Help with your Appeal

You may seek to obtain help with your appeal at the Unemployment Insurance Appeals Commission (Commission) or at a hearing before an administrative law judge (ALJ) if your case is remanded. **Below is a listing¹ of attorney and non-attorney agents who represent claimants, employers or both in appeals before the Unemployment Insurance Appeals Commission**². You are not required to have a representative. Your appeal will be considered by the Commission regardless of whether you have an attorney or agent represent you.

Some of the representatives offer their services for free, others charge a fee. It is your responsibility to contact the attorney or agent to determine the scope and cost of the representation.
