

Pine Lake Apartments Supportive Housing



The goal of the Pine Lake Apartments is to provide an alternative housing option to individuals associated with MCTI. For some individuals this is a first step into housing independence, utilizing this supportive housing opportunity to build a positive housing history. In the future, when a former tenant transitions into a more independent housing option; Pine Lake Apartments can be used as a housing reference; communicating rental payment history, apartment cleanliness, and personal behavior and conduct. A positive reference will assist with obtaining a future residence, whether it is in another apartment complex, or the purchase of a new home.

This complex is owned and operated by the Pine Lake Fund, a non-profit organization that is partnered with the Michigan Career and Technical Institute (MCTI) (This is a rural environment with very limited public transportation). It is located .5 miles from the MCTI main campus with 20 housing units. Ten of the units are MSHDA Low-Income qualifying.

The Pine Lake Apartments are a part of the MCTI Campus. Our location and partnership with MCTI provides a supportive housing environment. This includes support of MCTI campus rules and guidelines. While residing at the Pine Lake Apartments, tenants will be responsible to follow MCTI campus guidelines and rules.

Supportive Housing Eligibility

To be eligible for Supportive Housing, an individual must meet the following criteria:

- Current student status or graduate of MCTI, or individual with current MCTI affiliation
 - ✓ MCTI Students must be enrolled/actively attending vocational training / on-the-job training program that will lead to employment
 - ✓ MCTI Graduates must be gainfully employed
 - ✓ Have written support of a Vocational Counselor
- Meet the Resident Selection Policies and Criteria

As part of the Lease Agreement, residents remain eligible for housing as long as they actively follow MCTI, Pine Lake Apartment, and Supportive Housing policies and procedures.

What is the availability and cost?

Applications will be reviewed in the order in which they are received. Based on individual eligibility and unit availability, candidates may be placed on a waiting list when necessary. Currently, housing costs range from \$470-\$575 per month. MSHDA Low-Income range from \$325-\$375 per month if eligible. Housing costs include utilities, Wi-Fi, and local phone access. Security deposits are not required.

What will new tenants need to bring?

The housing units are fully furnished with a couch, chair, end tables, dining table/chairs, lamps, twin beds, dressers, desktop, desk chair, shower curtains, and all appliances. Vacuums, brooms, and cleaning supplies are available for checkout. Coin operated washers & dryers are available in each building. New tenants will need to bring dishes, pots & pans, kitchen utensils, bedding for twin beds, towels, telephone, TV & antenna, clock, and other personal products & clothing.

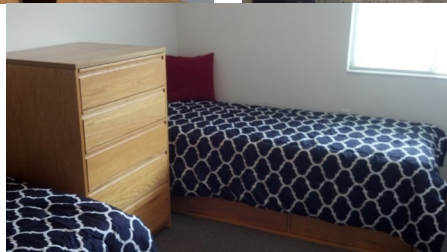
