This course will review the MIOSHA regulations found in Part 2 - Masonry Wall Bracing and is designed to teach the training requirements for working in the restricted zones, identification of the proper external bracing, minimum standards for bracing and securing unsupported masonry walls until final stability is achieved, and requirements for a competent person. **This course will satisfy the training requirements under Part 2 - Masonry Wall Bracing R408.40205(3) for employees working in the restricted zone. Virtual classroom with an in-person instructor. This training format can be taken from the office, home, or remotely.**
