Michigan Notable Books in the Detroit Free Press

January 6 the Detroit Free Press gave three pages to announcing the Michigan Notable Books program. We hope to continue this partnership in the future.

MLSA Passes

Reauthorization of MLSA is a vote of confidence in IMLS and its library grant programs through the Library Services and Technology Act. It is an explicit validation from members of Congress that an agency serving all their constituents—from job seekers and entrepreneurs to veterans and learners of all ages—deserves federal support. The new legislation authorizes IMLS through 2025 and contains improvements to enable more libraries on tribal lands to participate in IMLS grant programs, permit use of IMLS funding for disaster preparedness and assistance, and encourage greater use of data-driven tools to measure the impact and maximize the effectiveness of library services. While reauthorization of the legislation provides backing for IMLS, it does not ensure robust funding for the agency.

MCLS Executive Director Search

An announcement should be coming out soon naming the new Executive Director of MCLS. After interviewing 7 candidates the board has decided on who the next ED will be. Great candidates made the decision process challenging, but MCLS is in good hands with the new director choice.

Governor Whitmer's Landing Team

On December 7 the state librarian was part of a group that met with Gov. Whitmer's transition team to talk about the leading issues impacting the MDE and Library of Michigan.

FY 2017/18 Library of Michigan Annual Report

The annual report has been submitted to the legislature and is available.

Library of Michigan Foundation

No decision has been made by the board regarding the hiring of a new LM Foundation Executive Director. Darlene DePeel continues to maintain the day to day running of the office.

Improving Access to Information Grant Program (medium grants)

This LSTA grant program is designed to provide public and academic libraries with the opportunity to expand services for learning and access to information and/or to develop library services that provide all users access to information. The intent is to fund one-year projects that increase capacity to provide access to library collections and information. In a given fiscal year, the Library of Michigan will fund **a limited**

number of grants that meet these priorities.

GRANT PRIORITIES:

- Increase a library's capacity to offer services & information in areas of literacy.
- Increase a library's capacity to offer services & information in areas of local history or special collections.
- Increase a library's capacity to improve access to information for community users with limited access.

Applicants may propose a project for any of the three priorities listed. Grants may be awarded to:

- Develop or increase the scope of literacy projects in the broad sense, such as early literacy, financial literacy, digital literacy, ESL, etc.;
- Develop or improve access to local history or special collections;
- Improve access to online information and services for users with limited access.

APPLICANT ELIGIBILITY:

Michigan public and academic libraries. Eligibility will be confirmed by the Library of Michigan.

FUNDING AVAILABILITY:

The Library of Michigan announces each fiscal year whether competitive grant funds are available. The grant period is one year (Oct.-Sept.) and funding is for \$5,000 to \$25,000 per year.

PROGRAM TIMELINE:

- Application Due Date - Thursday, May 31, 2019, 5:00 PM EST
- Grants Awarded - August 2019
- Grants Begin - October 1, 2019
