Notification of Medical Marijuana Product Recall

The Marijuana Regulatory Agency (MRA) is issuing this health and safety advisory bulletin due to the presence of Vitamin E Acetate in several vape cartridges that failed safety compliance testing in December 2019 and February 2020. This recall also includes vape cartridges that did not have the required Vitamin E Acetate testing completed. These cartridges were manufactured prior to the Emergency Rules for marijuana products intended for inhalation filed on November 22, 2019.

All affected vape cartridges will have a label that indicates the license number of the marijuana facility that sold the marijuana product as well as tag number assigned to the product in the statewide monitoring system. Recalled products are listed below with the dates of sale in parenthesis and were sold at the following locations:
