This label must be in the possession of the user at the time of pesticide application.

GENERAL INFORMATION

Use Restrictions and Precautions

- Apply as required based on local thresholds.
- Avoid rescue situations.
- Apply with ground equipment or air equipment using sufficient water and application methods to obtain full coverage of the foliage.
- Use a minimum spray volume of 20 gallons per acre by ground or 5 gallons per acre by air.
- Add a quality, penetrating non-ionic surfactant or crop oil concentrate at manufacturer's recommended rate. Do not use sticker type adjuvants.
- See Agri-Mek label for comments on mixing with other products and crop phytotoxicity.
- Use a sound resistance management program including strategies found on the Agri-Mek label.
- Make 2 consecutive applications of Agri-Mek, then rotate to a chemistry with a different mode of action. Make at least 2 applications of a chemistry with a different mode of action before making additional Agri-Mek applications.
- Do not apply within 30 days of harvest.
- Do not apply at intervals less than 7 days.
- Do not apply more than 16 fluid ounces per application.
- Do not apply more than 48 fluid ounces per season.
- Do not apply this product through any type of irrigation system.
- Do not apply by ground within 25 ft., or by air within 150 ft., of lakes; reservoirs; rivers; permanent streams, marshes or natural ponds; estuaries and commercial fish farm ponds.
- Do not allow this product to drift onto non-target areas. Drift may result in illegal residues or injury to nontarget species. Risk of exposure to sensitive areas can be reduced by applying this product when the wind direction is away from the sensitive area.
- Do not apply when the weather conditions may cause drift.
- Do not apply when wind speed is below 2 mph because wind direction will vary and there is a high potential for inversion.

* Suppression means either erratic control ranging from good to poor or consistent control at a level below that which is generally considered acceptable for commercial control.
