

## **RECERTIFICATION – REREGISTRATION CREDIT REQUIREMENTS**

The Michigan Department of Agriculture and Rural Development (MDARD) and Michigan State University Extension (MSUE) developed the Recertification by Training Meeting Attendance Program in 1988. This program provides pesticide applicators with an optional method of renewing their certification/registration credential.

During your three-year certification/registration period (prior to expiration), you may obtain credits towards your recertification or reregistration by attending pre-approved pesticide applicator training meetings. Seminar credits are core or category specific. At the end of your certification/registration period, if you have earned the proper number of credits you can renew your credential without taking a renewal examination(s).

The number of credits required varies by applicator type (private, commercial, registered applicators) and the category(ies) or standard(s) that you are currently certified/registered in.

It is important for all applicators to keep track of the credits they have earned during their three-year certification/registration period. This information is necessary during the renewal process. ## SEMINAR ATTENDANCE RECORD

All recertification credits must be earned **prior** to your certification/registration credentials expiration date. Any extra credits will not carry over to your next certification period.

Commercial applicators and registered applicators must satisfy recertification requirements for each category; or take the examination for any category in which they lack sufficient credits. Each category requires category specific credits in addition to the commercial core credits. New categories can be added only by completing the examination.

Applicators that carry both private and commercial certification will need to earn 8 core credits and 8 category credits (total of 16) to cover both core credentials.

Aerial applicators must participate in Operation Safe Fly-In programs with their aircraft.
