**Notice of Letting of Intercounty Drain  
Contract and Review of Apportionments**

(In accordance with P.A. 40, of 1956, as amended)

**BUDD INTERCOUNTY DRAIN**  
(Arenac and Bay Counties)

**Notice is Hereby Given**, that we, Larry Davis, Arenac County Drain Commissioner, and Joseph Rivet, Bay County Drain Commissioner, State of Michigan, and Jamie Clover Adams, Director of the Michigan Department of Agriculture and Rural Development, will on **April 3, 2013, at the Arenac County Court House, Board of Commissioners Room, in the city of Standish, in Arenac County, proceed to receive sealed bids until 10:30 a.m. of that day**, when bids will be opened and publicly announced for the construction of a certain Drain known and designated as "Budd Intercounty Drain," located and established in Arenac County: Lincoln Township, and Standish Township; and Bay County: Pinconning Township. **All prospective bidders must attend and sign in at a Mandatory Pre-bid Meeting on March 27, 2013 at 10:00 A.M., at the Saganing Tribal Center, 5447 Sturman Road, Standish, Michigan, in order for their bids to be accepted.** Persons with disabilities needing accommodations for effective participation in the meeting should contact the Drain Commissioner in the county which they reside at the numbers noted below (voice) at least one week in advance of the meeting to request mobility, visual, hearing, or other assistance.

Said Drain is an open drain approximately 28,500 feet in length which is broken into 3 reaches. The first reach extends from Station 0+00 to Station 93+00 and has an average depth of approximately 7 feet and a bottom width ranging from 4 to 10 feet. The second reach extends from Station 93+00 to Station 165+00 and has an average depth of approximately 10 feet and an average bottom width of 4 feet. The third reach extends from Station 165+00 to the point of ending at the Saganing River and has an average depth of 5 feet and average bottom width of 4 feet. Side slopes in all reaches shall be 1.5 or 2 horizontal to 1 vertical or flatter. All stations are 100 feet apart. This Notice of Letting, the plans, specifications, and bid proposal shall be considered part of the contract. The following items will be required and a contract let for same:

Said job will be let in accordance with the plans and specifications now on file with the other documents pertaining to said drain, in the office of the County Drain Commissioners of the Counties of Arenac and Bay to which reference may be had by all parties interested. **Complete copies of the plans and specifications with required bid forms are available to prospective bidders at each county drain commissioner's offices for a non-refundable charge of \$50.00 for each set of plans.** Contracts will be made with the lowest responsible bidder giving adequate security for the performance of the work, in the sum then and there to be fixed by us, reserving to ourselves the right to reject any and all bids, and if no satisfactory sealed bids are received, we reserve the right to proceed immediately after the rejection of sealed bids and at the same time and place and without further notice to let the contract by open bidding, likewise reserving the right to reject any and all such open bids and to adjourn such letting to such time and place as we shall publicly announce.

Any persons desiring to bid on the above mentioned work will be required to deposit with the Drainage Board a cashier's check, money order, certified check or a bidders bond (cash is not acceptable) payable to the Budd Intercounty Drain Drainage District in the amount of 5% (five percent) of the bid amount as a guarantee that they will enter into contract and furnish the required insurance and bonds as prescribed by law. The checks of all unsuccessful bidders will be returned after contracts are awarded. All bids must be made on bidding blanks furnished by the Budd Intercounty Drain Drainage Board. All excavations shall be bid by a unit of linear measure or lump sum and not by volume. Payments will be cash upon approval of the engineer.

**Whereas**, The owner of any land or any county, city, village, or township in the Special Assessment District of the Budd Intercounty Drain who may feel aggrieved by the apportionment of benefits made

by the county drain commissioner, may within 10 days after the day of review, appeal therefrom by making application to the probate court of the county in which the assessed property is located for the appointment of a board of review. If drain assessments are collected by installment, a property owner or public corporations may pay the assessments in full with any interest to date at any time and thereby avoid further interest charges.
