**Notice of Drainage Board Meeting
for the Determination of Practicability**

COUNTY LINE INTERCOUNTY DRAIN

Notice is hereby given, that on May 13, 2014, a petition was filed with Richard Jakubiec, Isabella County Drain Commissioner, praying for the cleaning out, relocating, widening, deepening, straightening, tiling, extending, or relocating along a highway of a drain known and designated as the County Line Intercounty Drain.

Whereas, the Drainage District for the County Line Intercounty Drain includes lands within the following counties and their respective municipalities: Isabella County - Coe and Lincoln Townships; Gratiot County - Pine River Township; and

Whereas, a certified copy of said petition was served upon Brian Denman, Gratiot County Drain Commissioner; and Jamie Clover Adams, Director of the Michigan Department of Agriculture and Rural Development; by Richard Jakubiec, Isabella County Drain Commissioner.

Now therefore, in accordance with P.A. 40, of 1956, as amended, a Drainage Board meeting of the County Line Intercounty Drain will be held on **July 23, 2014**, at 10:00 a.m., at the **Coe Township Hall**, 309 W. Wright Avenue, Shepherd in the Township of Coe, County of Isabella, to determine the practicability of said improvement.

Now therefore, all persons owning lands liable to an assessment for benefits, or whose lands will be crossed by said drain, or any municipality affected, are requested to be present at said meeting, if they so desire. Public comment will be received at the meeting. Persons with disabilities needing accommodations for effective participation in the meeting should contact the Drain Commissioner in the county which they reside at the number noted below (voice) at least one week in advance of the meeting to request mobility, visual, hearing, or other assistance. 
