## Notice of Letting and Day of Review of Apportionments

### KNAPP INTERCOUNTY DRAIN (Lenawee and Hillsdale Counties)

#### NOTICE OF LETTING

The Knapp Intercounty Drain Drainage Board will meet on the above date, time and location to receive construction bids for the Knapp Intercounty Drain. Bids will then be opened and publicly announced.

The Knapp Intercounty Drain will be let in one section as follows, having the length, average depth and width as set forth:

***Install 7,402 lineal feet of dual-wall high-density polyethylene (HDPE) drain tile as follows: 5,000 lineal feet of 18-inch diameter with an average depth of 6.2 feet; 1,150 lineal feet of 15-inch diameter with an average depth of 7.1 feet; 1,252 lineal feet of 12-inch diameter with an average depth of 4.9 feet. Install three 18-inch diameter tee catch basins and one 4-foot diameter catch basin. Install agri-drain bar grates on all catch basins. Install inserta-tee connections as necessary to connect field tiles.***

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file at the offices of the Lenawee and Hillsdale County Drain Commissioners and available to interested parties. Bids will be made and received in accordance with these documents. Bidding Documents, including plans and specifications, may be examined at the following locations:

***Lenawee County Drain Commissioner's office; Hillsdale County Drain Commissioner's office.***

Copies of Bidding Documents may be obtained at no charge.

A security deposit in the form of a cashier's check, money order, certified check or

bidders bond shall be submitted with any bids. No cash will be permitted. The security deposits of all unsuccessful bidders shall be returned after the Contract is awarded.

The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work and meeting all conditions represented in the Instructions to Bidders. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.

The Day of Review is an opportunity to review the tentative apportionment of benefit for each parcel and municipality within the Intercounty Drainage District.

The Drain Commissioner, engineers and/or other staff members will be available to assist individuals throughout the day, and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Intercounty Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Drain Commissioner of their County at the number listed above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

You may appeal the Drain Commissioner's determination of apportionments to the Probate Court in the county in which you reside within ten (10) days.

The following is a description of the several tracts or parcels of lands constituting the Special Assessment District of the Knapp Intercounty Drain, as well as a list of any county, township, city, village to be assessed at large:

***Part of the Southeast ¼ of the Southeast ¼ of Section 36; Town 6 South and Range 1 West, Wheatfield Township, Hillsdale County. Part of the East ½ of Section 1; Town 7 South and Range 1 West, Pittsford Township, Hillsdale County. Part of the West ½ of Section 6; Town 7 South and Range***

**1 East, Hudson Township, Lenawee County, Michigan.**

**Hillsdale County for benefits to public roads; Wheatfield Township and Pittsford Township at large for benefits to public health, convenience and welfare.**

**Hudson Township at large for benefits to public health, convenience and welfare.**

**Michigan Department of Transportation at large for benefits to state highway US-127.**
