SYSTEM COMMITTEE REPORTS FOREST, WETLANDS AND HABITAT

Jason Darling read through the handout of recommended changes. (shared screen) Jason reported that the FWH Sub-committee had man discussions on changing the heading for the column "Records or Evidence for MAEAP Verification".

The tool will use the heading "Referencing Information".

Jason walked through the Summary of Recommended changes, noting that the web-links will be removed, and they will remove the reference fact sheet section, and build it into Table 2.

Ben Schram added that special sites are standard in the American Tree Farm Association tool, and is required for someone to be certified in the American Tree Farm Association, not an environmental issues, but keeps it a mention of special sites to keep it consistent.

1.10b) suggested to update the language as it sounds vague, Jason will add some more language into this question. "To the best of their knowledge, is the landowner aware of any unused well, or abandoned well.

FOREST, WETLANDS AND HABITAT SYSTEM SUB-COMMITTEE (continued)

Josh Appleby noted that the question should remain consistent between A*Systs. The standard question in the current Farm*A*Syst will be used regarding abandoned wells.

CROPPING SYSTEM SUB-COMMITTEE

Josh Appleby read through the handout of recommended changes to the Greenhouse*A*Syst.

The suggested changes this year involve consistency between all the other Crop*A*Systs.

LIVESTOCK SYSTEM SUB-COMMITTEE

Josh Appleby read through the handout with recommended changes to the Livestock*A*Syst.

Josh explained the new language in the Siting GAAMPs. The guidance will do a better job helping farmers and technicians to have a systematic way to figure out siting issues.

The proposal is to remove all existing questions and replace them with one new question that asks, "Site Selection GAAMPs were approved." This means they will have an official letter that states the low and medium risk columns have been met.

This provides an opportunity to work with other MDARD staff asking questions, relying on farmers information, then gives the opportunity for Right to Farm staff to review the proper year of the GAAMP.
