RE: WARN NOTICE OF LAYOFF

Dear Mr. Houck:

This is to notify you, pursuant to the provisions of the Worker Adjustment and Retraining Act, that Asplundh Tree Expert Co. was formally notified on Monday, October 22, 2001, by Detroit Edison of a mandatory cutback in work. At that time, the following number of employees were laid off. We have not been advised by Detroit Edison on when or to what extent work will restart.


This notice is being given less than 60 days prior to the layoffs due to the fact that Asplundh received notice on October 22, 2001 from its customer, Detroit Edison, that the
