Dear Public Officials:

This letter is to inform you that Blue Care Network (BCN) is permanently closing our Family Health Center located at 1401 S. Creyts Road, Lansing, Michigan. Although other BCN and BCBSM administrative operations may continue at this location, the entire BCN Family Health Center is closing. We expect this closing to occur during the 14-day window beginning September 16, 2009. In accordance with the Worker Adjustment and Retraining Notification Act, 20 USC Section 2101, the following information is provided to you regarding this closing.

Some affected employees will be given the opportunity to pursue other job opportunities within the company. Affected employees who have not found positions within the company at the end of their 60-day notification period will be separated from the company during the 14-day window beginning September 16, 2009.
