
Dott is closing its facility is located at 3768 North Main Street, Deckerville, Michigan 48427. The entire facility will be closing permanently. The closing will affect a total of 184 employees.

At this time, we expect the layoffs to be completed and the facility to be closed by approximately March 26, 2009.
