In accordance with Sections 3 and 7 of the Worker Adjustment Retraining and Notification Act, The Great Atlantic & Pacific Tea Company, Inc. ("the Company") hereby gives notice that it is in negotiations for the potential sale of its operations in the Midwest, which is comprised of 66 Farmer Jack grocery stores in the counties of Wayne, Oakland, St. Clair, Macomb, Genesee, Livingston, Monroe and Lapeer, as well as an administrative office and warehouse located at 28700 Plymouth Road, Livonia, MI 48150. A list of the 66 store locations is attached. The current number of employees at all of these locations totals approximately 5,775.

The Company anticipates the sale of groups of stores to selected bidders. As of today's date, it is not possible to determine precisely which employees may reasonably be expected to experience an employment loss as a consequence of these various proposed transactions. This notice will be supplemented as definitive acquisition agreements are reached and details regarding employment status are more clear.
