This letter is written pursuant to the Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 et seq., to notify you that Faurecia Automotive Seating, Inc. ("Faurecia") currently expects to permanently close its Shelby, Michigan manufacturing facility, located at 6200 26 Mile Road, Shelby Township, MI 48316, commencing on August 22, 2009.


It is currently anticipated that the plant closing will occur during the 14-day period between August 22, 2009 and September 4, 2009. Some dismantling of equipment and machinery may occur after the plant closing. Faurecia currently anticipates that this plant closing will be permanent and will affect 111 non-union employees. We have enclosed a list of the job classifications that will be affected by the plant closing and the number of employees who will be affected in each of those job classifications. The affected employees do not have bumping rights.

Auburn Hills, Michigan Facility**

Dear Ms. Canfora:

This letter is written pursuant to the Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 et seq., to notify you that Faurecia Automotive Seating, Inc. ("Faurecia") currently expects to temporarily close and idle its Auburn Hills, Michigan manufacturing facility, located at 2800 Superior Court, Auburn Hills, MI 48326, commencing on August 22, 2009.

It is currently anticipated that the idling of the Auburn Hills facility will occur during the 14-day period between August 22, 2009 and September 4, 2009. Some dismantling of equipment and machinery may occur after the idling of the Auburn Hills facility. Faurecia currently anticipates that this plant closing will be temporary and will result in temporary but indefinite layoffs of 20 non-union employees and 167 union-represented employees. Given the economic uncertainties facing the automotive industry generally and Faurecia and the Auburn Hills facility's primary customer, GM, in particular, the duration of the layoff cannot at this time be determined. It is possible that this layoff could extend beyond six months. It is also possible that the Auburn Hills facility may ultimately be permanently closed, in which case, these layoffs would become permanent.

We have enclosed a list of the job classifications that will be affected by the temporary plant closing and the number of employees who will be affected in each of those job classifications. The affected employees do not have bumping rights to displace other employees from their jobs due to the layoffs associated with the temporary plant closing.

The affected union-represented employees are represented by the International Union, United Automobile, Aerospace and Agricultural Implement Workers of America, UAW Local 5960. The names and addresses of the chief elected officers of the international and local union are as follows:

Dear Ms. Canfora:

In a letter dated June 18, 2009, written pursuant to the Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 et seq., we notified you that Faurecia Automotive Seating, Inc. ("Faurecia") expected to permanently close its Shelby, Michigan manufacturing facility, located at 6200 26 Mile Road, Shelby Township, MI 48316, during the 14-day period between August 22, 2009 and September 4, 2009. Faurecia has now determined that the closing of the Shelby facility and the termination of employees in connection with that plant closing must be postponed.

In the June 18 letter, we informed you that the information and notice in that letter were based on the best information then available concerning General Motors' plans for its Lake Orion manufacturing facility and the impact those plans would have on Faurecia's Shelby facility. It is now apparent that GM will not cease production at its Lake Orion facility by early September, as originally anticipated. It now appears, based on the best information we currently have available from GM, that production at the Lake Orion facility will now cease in late November 2009. Accordingly, the closure of Faurecia's Shelby facility has been postponed.


Some dismantling of equipment and machinery may occur after the plant closing. Faurecia currently anticipates that this plant closing will be permanent and will affect 88 non-union employees between November 23, 2009 and December 2009, and 12 employees between September 18, 2009 and October 1, 2009. We have enclosed a list of the job classification that will be affected September 18, 2009 to October 1, 2009. The affected employees do not have bumping rights.
